Thank you for giving me the unsigned proposal of Karen Pharoah Murphy dated August 13 2013. I would like a copy of the executed signed agreement, proposal and/or contract between Karen Pharoah Murphy (the independent lighting consultant) and/or her employer HDR and whomever the agreement is supposed to be with.
