At the July 8, 2014 Worcester BOS Meeting, Supervisor Bustard referenced receiving emails from individuals complaining about, "bullying that people are responding to when they say that they don't want the gravity system." I have heard just the opposite in that those who prefer the gravity system are being "actively lobbied" or as you may describe it "bullied" by at least 1 Supervisor when they try to express their concerns and preference for the gravity system.

That being said, I would like copies of,
