Right to Know Officer,

Resolution No. 08-26 was adopted by the Worcester Board of Supervisors on December 1, 2008.

The Resolution authorized the Township to contribute \$15,000 to Cindy Welsh Haines to "defray expenses incurred in the negotiation, preparation and recording of the conservatory easement and related documents."

As part of RTK request No. 13-1048, I discovered that only \$5,000 dollars was expensed for legal services associated with the Conservatory Easement. It appears that the remaining \$10,000 was a donation to the Conservancy of Montgomery County.

The following is a request for records made pursuant to the Right to Know Law ("RTKL"). Please be advised, the term "record" and "records" as used is defined under the Right to Know Law ("RTKL") as "Information, regardless of physical form or characteristics, that documents a transaction or activity of an agency and that is created, received or retained pursuant to law or in connection with a transaction, business or activity of the agency. The term includes a document, paper, letter, map, book, tape, photograph, film or sound recording, information stored or maintained electronically and a data-processed or image-processed document."

In light of the foregoing, the following records are requested,

1. Any and/or all documentation including but not limited to letters, memos, emails, and/or canceled checks (these ARE available in reduced format per Eunice) that would verify that \$10,000 was donated to the Conservancy of Montgomery County in relation to Resolution 08-26.
2. Any and/or all documentation including but not limited to letters, memos, emails, and/or canceled checks (these ARE available in reduced format per Eunice) verifying any donation to the Conservancy of Montgomery County in Relation to Resolution 08-26 made on behalf of Worcester Township and/or Cindy Welsh Haines.
3. Any and/or all confirmation documents from the Conservancy of Montgomery County verifying acceptance of any donations from Worcester Township, Worcester Township on Behalf of Cindy Welsh Haines and/or Cindy Welsh Haines.
4. Any and/or all communications and/or documents between Cindy Welsh Haines and/or anyone authorized to represent Ms. Haines and the Worcester Board of Supervisors collectively and/or individually regarding Resolution 08-25, the negotiation, preparation, resolution and recording of the conservatory easement and related documents and the allocation of the \$15,000 dollars of taxpayer funds.
5. Any and/or all communications and/or documents between Cindy Welsh Haines and/or anyone authorized to represent Ms. Haines and the Township Manager regarding Resolution 08-25, the negotiation, preparation, resolution and recording of the conservatory easement and related documents and the allocation of the \$15,000 dollars of taxpayer funds.
6. Any and/or all communications and/or documents between Cindy Welsh Haines and/or anyone authorized to represent Ms. Haines and the Township Solicitor regarding Resolution 08-25, the negotiation, preparation, resolution and recording of the conservatory easement and related documents and the allocation of the \$15,000 dollars of taxpayer funds.
7. Any and/or all communications and/or documents between Cindy Welsh Haines and/or anyone authorized to represent Ms. Haines and the Township Manager and/or Board of Supervisors collectively and/or individually regarding the possibility of a "Map Change".

8. Any and/or all communications and/or documents between Board of Supervisors collectively and/or individually regarding the possibility of a "Map Change".
9. Any and/or all documents verifying the entire \$15,000 of taxpayer funds expended by Cindy Welsh Haines associated with Resolution No. 08-26 used to "defray expenses incurred in the negotiation, preparation and recording of the conservatory easement and related documents."
