The following is a request for records made pursuant to the Right to Know Law ("RTKL"). In light of the foregoing, copies of the following records are requested,

7. Please provide copies of any and/or all invoices submitted by any and/or all individual(s), entity and/or entities other than the Township Engineer and the Township Solicitor regarding the Township's "Light Ordinance", monthly, for the years 2010, 2011, 2012, 2013, 2014, and 2015.
8. Any and/or all Client Billing Summary's for any and/or all work performed by the Township Solicitor's Law Firm regarding OOR AP 2015-2495 and the associated Township denial of RTK request No. 15-1402, monthly from January 1, 2015 to present, .
