Right to Know Officer,

The following is a request for records made pursuant to the Right to Know Law ("RTKL"). Please be advised, the term "record" and "records" as used is defined under the Right to Know Law ("RTKL") as "Information, regardless of physical form or characteristics, that documents a transaction or activity of an agency and that is created, received or retained pursuant to law or in connection with a transaction, business or activity of the agency. The term includes a document, paper, letter, map, book, tape, photograph, film or sound recording, information stored or maintained electronically and a data-processed or image-processed document."

In light of the foregoing, copies of the following records are requested,

1. Copies of any and/or all detailed billing invoices for legal services submitted by James Garrity and/or his law firm Wisler, Pearlstine (the Township Solicitor's Firm) to Worcester Township for the entire months of April, May and June of 2016. These would also correlate with the monthly payment of the bills check registers as a result of the timing of their submission.
2. Copies of any and/or all detailed billing invoices for legal services submitted by James Garrity and/or his law firm Wisler, Pearlstine (the Township Solicitor's Firm) to Worcester Township referenced in the payment of the bills section of the 7/20/16 BOS meeting totaling \$6,541.03.
3. The document and/or documents that would show the total amount expended to date on the acquisition of the Nike Army Base, including but not limited to legal costs, LRA expenses, consultant fees and allocated to any capital reserve funds.
4. The document and/or document that would show the current total amount to date in the capital reserve fund for the Nike Army Base.
5. Any and/or all billing summaries from the Manko Firm and/or any of its partners, associates and/or employees, dealing with the Nike Army Base, monthly, for the years 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015 and 2016.
6. Any and/or all billing summaries from James Garrity and his Law Firm Wisler Pearlstine dealing with any aspect of the Nike Army Base, including but not limited to the LRA, monthly, for the years 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015 and 2016.
7. A copy of the first Township budget in which money was allocated to be used for the Nike Army Base.

8. A copy of any and or all AP check register reports that would show the total amount expended to date on the acquisition of the Nike Army Base, including but not limited to legal costs, LRA expenses, consultant fees.
