RTK Officer,

The following is a request for records made pursuant to the Right to Know Law ("RTKL"). Please be advised, the term "record" and "records" as used is defined under the Right to Know Law ("RTKL") as "Information, regardless of physical form or characteristics, that documents a transaction or activity of an agency and that is created, received or retained pursuant to law or in connection with a transaction, business or activity of the agency. The term includes a document, paper, letter, map, book, tape, photograph, film or sound recording, information stored or maintained electronically and a data-processed or image-processed document."

At the recent Township Meeting Supervisor Caughlan suggested that the "Plan" for what the Township intends to do with the Nike Army Base, once conveyed, is readily available for review for Township residents. I have not been able to locate it.

I would therefore request the following,

1. Any and/or all records of communication including but not limited to emails, notes, memos, and/or faxes to and/or from the Worcester Board of Supervisors collectively and/or individually regarding the Nike Army Reserve Base including but not limited to plans for the possible acquisition and/or the intended utilization of the property before and/or after being acquired by the Township, and/or any environmental concerns and/or the presence of toxic and/or hazardous materials, monthly, from July 2016 to present.
2. Any and/or all records of communication including but not limited to emails, notes, memos, and/or faxes to and/or from the Township Manager regarding the Nike Army Reserve Base including but not limited to plans for the acquisition and/or the intended utilization of the property before and/or after being acquired by the Township, and/or any environmental concerns and/or the presence of toxic and/or hazardous materials present at the site, monthly, from July 2016 to present.
3. Any and/or all records of communication including but not limited to emails, notes, memos, and/or faxes to and/or from the Law Firm of Manko, Gold, Katcher and Fox and/or anyone in that law firm regarding the Nike Army Reserve Base including but not limited to plans for the acquisition and/or the intended utilization of the property before and/or after being acquired by the Township, and/or any environmental concerns and/or the presence of toxic and/or hazardous materials at the site, monthly, from July 2016 to present .
