## **USE OF HEYSER FIELD POLICY**

Certain areas of the municipal buildings are available for use by public township-based groups or organizations based on the following procedures:

1. Interested parties shall contact the office of the Township Manager to confirm availability of the ring at least 72 hours prior to desired date.
2. The facility available is the Heyser Field Riding Ring behind the Fairview Village Assembly Hall. No municipal materials or equipment will be supplied for use.
3. Heyser Field Ring does not include use of the Fairview Village Community Hall. A separate application and fee is required for that facility.
4. The meeting of the organization shall be open to all residents of the Township free of any admission charge.
5. The Ring may be reserved for a single event. Multiple events or regular use throughout the year is subject to availability and a separate application must be made for each use. Official Township business meetings, scheduled or special, take precedence over other group meetings.
6. The facility is available seven days a week from 8:00 A.M. through 10:00 P.M.
7. Repair for any damage to the facility shall be promptly paid by the group in compliance with applicable law.
8. Future use of the facility can be denied, if prior use by a group or organization caused damage to the Township property or was disruptive to the Township operation.
9. Children under 18 must be accompanied by an adult at all times.
10. No group may discriminate on the basis of race, color, religion, creed, gender, national origin, age disability, marital or veteran status, or sexual orientation.
