A RESOLUTION SIGNIFYING THE APPROVAL OF THE
BOARD OF SUPERVISORS OF WORCESTER TOWNSHIP
TO ACCEPT CREDLEY LANE AS PART OF THE
TOWNSHIP'S PUBLIC ROAD SYSTEM

WHEREAS, Patricia Berardelli has requested the Board of Supervisors of Worcester Township, to accept as part of the township's public road system a certain road, known as Credley Lane, as shown on a plan of subdivision dated _____ as the same appears recorded in the Office of the Recorder of Deeds of Montgomery County, Pennsylvania in Plan Book _____ at Page _____, which said road, as laid out and presented for acceptance as a public road, is more fully described in the deed offering said road for dedication, which is attached hereto and incorporated herein by reference; and

WHEREAS, said road above-described has been laid out, opened, improved and constructed in accordance with the specifications of Worcester Township; and

WHEREAS, the area embraced by said road is a residential area and the owners and future owners of said land are in need of having Credley Lane made a public road:

Therefore, it is hereby RESOLVED that the request of Patricia Berardelli is hereby approved and the deed and release delivered by Patricia Berardelli, dated November 4, 1985,


offering said road for dedication is hereby accepted and Worcester Township hereby adopts Credley Lane therein described as part of the township's public road system.
