- a) Motion to authorize Township Solicitor to prepare a Resolution approving the 1543 Trooper Road Lot Line Change with the condition that no prior deed restrictions are being broken.
- b) Motion to approve a waiver of land development for the waiver of land development application 2024-01, Pennsylvania American Water Company, 2523 Skippack Pike, for a material storage structure.
